

This is a critical process that enables tax authorities to ensure the accuracy and integrity of tax returns and address any potential tax evasions. The decision to reopen a tax assessment should be based on valid grounds and supported by credible and tangible evidence with 'onus to prove' on the department rather than reopening on the basis of 'any information uploaded on Insight Portal".
